- 150 – 2”x8”x16’ Pressure Treated Lumber
- 10 – 6”x6”x16’ Pressure Treated Lumber
- 6 – 12”x12”x16’ Pressure Treated Lumber
- 2,000 - 4" X .131 Smooth Shank 15-degree Coil Framing Nails (Thickcoat galvanized finish with a diamond point and smooth shank). For use with BOSTITCH tools N100C, N40.

All pressure-treated lumber should be stamped/tagged for direct burial and be No 1 grade or better.
